Introduction:

Thank you for considering us to advertise with! We are happy to have you in the Spiritual SA family. Please read through and consider the following terms before purchasing a listing on the website. Established and approved spiritual businesses are able to advertise their products, services or other offerings on our website. Available to you upon purchase is one or more (dependant on the purchase tier) listings on the website and the ability to feature your products, services and other offerings.

This document and all of its content serves as a resource for people/groups/businesses purchasing a listing on the spiritualsa.com.au domain. All of the content published herein forms the totality of what is called the 'Terms & Conditions for Membership'.

The spiritualsa.com.au domain is an asset of the registered business "The Spiritual Community of South Australia", and its registered trading name "Spiritual SA", of ABN: 88 362 929 565.

This iteration is the 1st edition of the Terms & Conditions for Membership, effective date: 17/03/2025.

Who is who? Definitions:

When stated in this document, the following terms have the following meanings:

"Member" designates a person or business that has an active, paid subscription membership to this platform and thereby has a "listing". This is distinct to a user account that is free. Only paid members have an active listing on this website, unless held directly by the website owner.

The terms "customer" and "client" designate prospective or actual purchasers of a member's products or services, respectively. The term "student" designates a person who studies under a practitioner. The term "participant" designates a person who attends an event.

"Admin" designates the owner and employed/contracted workers of this website.

"We", "us" and "our" on this page refer collectively to the owner and admin of this website.

"You" refers to any holder of an active business listing who has agreed to this "Terms" document.

"Website" refers to the business and trading names of 'The Spiritual Community of South Australia' and 'Spiritual SA' respectively, and the entire digital platform of the domain spiritualsa.com.au.

Perks of Being a Member:

- Reach thousands of people who want to find your services, products and other offerings!
 - Focus your advertising to people who are local to your business
 - Become less dependent on social media platforms and their algorithms
- You may not have to advertise as frequently through other channels, saving you time and money
 - What you pay for your listing(s) is claimable through tax
- A percentage (undisclosed) of the money poured into the platform goes back into promoting the website and spirituality in South Australia
- There is no yearly contract to sign, payments are made monthly, and you can exit at any time

Who Are Encouraged to Be Members? Eligibility Criteria:

Short answer: approved spiritual businesses operating in or from South Australia!

The Type of Business We are Seeking:

1. Be over 18 and an Australian citizen (**required**)
2. Be living in or working in South Australia (**required**)
3. Professional and established businesses, preferably with an ABN, business name, public phone number, email address, website and 1+ social media account(s). You are very welcome to still join the platform without a few of these things!
4. Community-driven and ethically focused in business, having a sound mind and good character
5. Holding all necessary qualifications and adequate experience in one's disciplines and operations
6. An intention of staying in the spiritual industry as a livelihood or continued side-hustle

****If you are located outside of SA, but still in Australia, you may contact admin to have a listing with Spiritual SA. Our policy is that you will at least once annually hold an in-person event in SA.**

Some Exclusions for Entering this Platform:

1. Being a practitioner or business that is not residing in or working in South Australia. Online spiritual businesses operating outside of South Australia are not accepted.
2. Being a business that is non-spiritual in nature. Some examples of excluded modalities and services are: secular (non-spiritual) counselling and psychology, nursing and medical clinics, MLM (multi-level marketing) businesses, charities and fundraisers, fraternal organisations, tattoo artists, piercings, beauty therapists, marriage celebrants, non-spiritual event organisers, real estate agents, financial consultants, physiotherapy and chiropractic.
3. Being a religious organisation or attempting to proselytise. Spiritualist churches are accepted on this platform and are recognised as spiritual.
4. This platform will not be accepting practitioners who engage in sexual work or gratification for clients. We also do not accept practitioners and businesses who sell their own nudity or sexuality. There is a light policy of modesty attached to this platform that is taken on a case-by-case basis. We want this website to remain family-friendly.
5. We do not accept coaches who specialise only in money matters (inc. crypto) or weight loss.
6. Any anti-spiritual sentiment or activity will not be tolerated on our platform.

Your Credentials:

While this website aims to grow people's spiritual business, those who have very little or no experience are discouraged from creating a listing with us, until such time as enough experience has been gained. Then you are most welcome to join! This can be done through friends, family, relevant work placement or having a stall at a market fair. We take inexperience on a case-by-case basis, and you may call us to warmly discuss where your new business stands.

- To the best of your ability, you must hold all necessary certificates and licenses to be able to practice your modalities. Recognition of prior learning is accepted for those who have gained years or decades worth of experience while not holding industry-specific certificates
- Any practitioner who works with children as a service must provide an email to admin of a current 'Police Check' clearance and 'Working with Children' certificate (**required**)
- Hold public liability/professional indemnity or product insurance. It is recommended to have cover of \$10M and above

After purchasing a listing package, simply create your listing and we will contact you for your required credentials. Refer to the Privacy Policy in this document for peace of mind.



Price: free

By having a user account, you agree to act in accord with the ethics of this website, explained on the “Legals” and “About” pages. Breach of these values may result in the termination of your free account. 0 listings.



SINGLE BUSINESS LISTING

Price: \$8 monthly

A single business listing that appears on the Spiritual SA website for the public to see. You are able to create and edit a listing, display links and images, input a map location, show your working hours, and attach relevant tags and amenities, + more. Light help from admin is available to you to get your listing up and running. 1 listing and Instagram ads included.



PREMIUM: MULTIPLE LISTINGS

Price: \$14 monthly

A package for those who run a shop + personal practice, or for larger franchises that have more than 1 site in SA. On top of what's included in a single listing, this tier allows you to “feature” one of your listings. For a listing to be featured, it will appear above other businesses in search results, allowing your listing to be seen by more people. Limited admin edits per month apply. Up to 2 listings and Instagram ads included.

Membership with the Website:

****You must have an account and login to be able to purchase a listing.**

When purchasing a listing, include your legal name and genuine billing address. Admin will need positive identification of all listed businesses and practitioners (kept private). We may contact you for proof of name, age, citizenship status or SA residency. We do not accept stage names/aliases as ID. (**required**)

Membership is an ongoing, monthly subscription. Membership fees are paid in advance and afford you one month's worth of public listing publication on the spiritualsa.com.au website.

When you initially purchase a package, you are immediately able to create a listing. Your banking information is not stored by admin, but is securely transacted through the website's payment gateway (Stripe). After your initial purchase, a secure payment link will be sent to establish your recurring monthly payment. All paid memberships are automatically charged monthly via the merchant service (Square).

If you wish to have more than one package, you may simply purchase more single packages as separate sales. The software of the website does not allow 2 or more of one particular package tier to be purchased at once. Buying more than one listing is a benefit for businesses with multiple sites, franchises or people who operate more than one business and wish to display them as separate listings.

When you buy an even number of listings, Spiritual SA will consolidate your packages into the "Premium: Multiple Listings" tier, which will save you \$2 per month. We will cancel an existing singular (odd-numbered) subscription and provide another secure payment link in order to consolidate your even number of listings.

If you change your mind in this payment setup process, or fail to input your details using the Square payment link within 30 days, any single listing that is provisionally awaiting establishment of recurring payments will be placed into a draft mode not accessible by the public. In order to have a listing displayed indefinitely on our website, you must input your details twice (once through the website, and once through the payment link).

Cancellation of Your Listing:

You may cancel your subscription at any time by clicking on the subscription settings on any Square email receipt provided to you by Spiritual SA. After this cancellation, your listing will be placed into private draft mode. Listed businesses that have cancelled their subscription in the past are welcome back to the platform, provided they are approved to do so and adhere to all terms again. If you unintentionally input your details for the monthly payment, you can cancel the subscription at your own initiative. If you are having issues with cancelling, you may contact admin for us to promptly cancel your subscription.

Refund Policy:

There will be no refunds issued for any tier of membership due to the low cost of these membership fees per month. Any money Spiritual SA receives from accidental purchases of listings, purchases from businesses that breach the eligibility criteria, user-initiated cancellation within a paid month, waiting too long to cancel, or payments from listings that necessitate membership termination, are to be considered donations to this website platform. By purchasing a listing, you agree to these terms.

Your Profile and Listing Creation/Edit:

Account Button:

Where you go to view your orders and change your account password. Only admin is authorised to change your username, which you may request. Click the Membership Profile button to return to the Profile overview button menu.

Profile:

Simply a landing page for you to further browse your own details, create listings and make edits.

Edit Profile:

Here you can input your contact details for admin to be able to contact you. None of what is input in this area of the Profile shows publicly on any of your listings. You may change your password here. Admin can change your password, only upon your request, if you happen to lose it.

My Packages:

This area shows you details about your previous purchases, including how many listings are yet to be created or able to be featured in searches. The status of “active” in this section simply refers to the first month after purchase, after which, and upon setting up a recurring payment, your listing remains displayed.

Add Listing:

The place to get your listing creation started. If there happens to be an issue with creating a listing after purchasing a package, admin can create a blank listing and assign it to your user account, ready for you to customise.

You are encouraged to input as much relevant and truthful info for your listings as practical (up to around 500 words). If admin observes obvious errors in your attachment of category, tag, amenity, or other fine details, admin reserves the right to alter these parts of your listing on the backend of the website. If you feel an alteration has been made to your listing in error by admin, contact us to rectify the issue.

After making any changes to your listing, remember to click the button at the bottom of the page that says “edit listing” to save your changes.

Meanings of the various elements of listing creation/edit are as follows:

Listing Is Featured: For your listing to appear at the top of user searches on the website. Your listing(s) can only be featured in searches if you have paid for a Premium package.

Listing Item ID: [redundant, n/a]

Title: The name of your business that will appear as the title in your paid listing and in searches.

Excerpt: A short blurb about your business, appearing in search results. Be succinct. The excerpt is maximum 72 characters long. Any more text you input will be hidden and may look unprofessional.

Description: Your bio text that appears in your paid listing. This is the space to tell the public everything you do; the hows, wheres, whens, whos and whys of your business.

Title Logo Image: Your profile image that appears next to your title in the paid listing.

Featured Image: Your profile image that appears in search results (yes, they are different).

Gallery Images: This is the section to input images for your slider, which is the image carousel at the top of paid listings. ***Note:** you may have to upload all intended images at once. Re-pressing upload may cancel all previous gallery images. It is recommended for you to have all desired images (up to 6) in one folder on mobile and PC, or easily earmarked/accessed, so you can click them all at once. For PC, simply highlight all image files and click upload. For mobile, press and hold an image file so a tick appears, then press to tick all other desired images to upload. Contact admin if you are experiencing issues.

Category: Tick which modalities and other offerings you professionally offer for the public to purchase or attend. Choosing the relevant categories for your business will require you to comb through all of them. Unfortunately, the categories in this section cannot be listed under parent headings (numbered). Choose “other” within a parent category when you operate a spiritual or allied modality that is not listed. Make sure the offering falls within the selected category and aligns to the ethics of this website.

Tag: Tags are available for showing your clients your personality type. Do not tick them all if certain particulars do not apply to you.

Location: The “City” field is in fact the suburb you work in or are very near to. The “Full Address” field is to input what map marker you would like users to see on your listing. The “Latitude” and “Longitude” areas fill automatically. You may choose to only key in a suburb or a street name for privacy’s sake.

Contact Information: **Very important. These are the fields that are seen by the public on your listing Contact Info section. If you input a wrong email, the 'Contact This Business' button will send messages to that wrong email. That button is tied directly to your exact email input by you.

Social Information: Where to input your official social media websites relevant to your listing business.

Amenity Section: These are meant to show your clients, customers, students and attendees what accommodations you are able to provide for their convenience and peace of mind.

Reviews Criteria Section: [redundant, n/a] Spiritual SA does not offer reviews on listings at this time, and will remove the ability to do so on every listing. This may be revisited in the future.

Business Hours Section: You may choose to display business hours on your listing, appearing in the Contact Info block. You can also choose not to display any business hours info and direct people to booking links, or allow them to contact you for availability, instead.

Additional Info Section: An additional links section. "Label" is the explanation assigned to the link. "Value" is the link text. "Value Link" is the web address people will reach when clicking the "Value" text. If you do not understand how web links work, forgo this part of the listing.

My Listings:

At any time, here you can preview your paid listings, edit them and delete them. While the website asks you if you are sure to delete a listing, please be careful not to press the delete button + 'yes' accidentally, as the listing will delete permanently from the website and not be recoverable from any draft mode.

My Wishlist:

On top of your business advertising, you are also a user of the website, and you may wish to save your favourite listings of other businesses and practitioners for personal or professional reasons.

My Searches:

You can save any particular searches of listings on the website and recover the search results here.

Reported:

This is where reporting of your listing is noted. Admin will be involved in the process if there happens to be content on your listing that breaches these Terms.

Claimed:

A redundant button for directories that take public details of businesses and create listings without their permission. This is actually legal, provided they do not display copyrighted content. However, this is not the philosophy of Spiritual SA and we will not ever create a listing without permission. This means no user would need to claim a listing as their own, as they will have paid for theirs on this website.

Log out:

Click this button to logout of your user account with Spiritual SA for that particular device.

- **Extraneous:** Photography, Martial Arts, and Personal Training.

Contact admin to request any of these or to suggest any more category additions.

Our Policies for Locations in Your Listing:

The location of your listing is exclusively the place or suburb your business physically operates in. If you have a physical, bricks-and-mortar shop/centre, it is required to key in the exact address of your workplace. By inputting any exact business address – whether it is your home, a shop, a centre or other – on your listing, you agree to this information being publicly displayed.

If you frequently work at multiple worksites, you may contact admin to attach all other business locations to your listing. We also recommend you mention your current and relevant credentials somewhere in your bio area.

****You are highly recommended to make small changes, update them and preview them as you go,** instead of trying to input all listing particulars at once. It is much more user-friendly to use a laptop or PC in order to create/edit your listing. You are able, but not recommended, to do the same on tablet or mobile.

Admin can show you what links to click in order to create/edit your listing or user profile. We, however, do not currently offer copyrighting services or IT help for people who are not tech savvy. All listing holders must write their own bio and be able to operate the backend area of their user profile. In the interest of valuing human creativity and customer/client dignity, we do not endorse the use of AI to create your bio.

Because so much info of yours is contained in one easily accessed place, you may wish to use your unique listing link to share to your followers on social media! Simply copy your link from the browser bar.

- Use correct grammar, punctuation and a thoughtful bio structure. This helps Google make your particular listing visible in searches
- Maintain a professional tone

Our Policies for Your Listing Images:

This can be a great way to showcase products, services, happy clients, venues, clinics and other workspaces. All photos provided by you to this platform are to be sensible and relevant to your business. What is deemed to be sensible for your listing(s) images is solely at the discretion of admin. A rule of thumb is to upload images that are family-friendly and palatable for people of all ages and personalities to view.

Ethics Promotion:

A full and expanded code of ethics and conduct for the spiritual industry is being developed by the owner of this website and will be available as a separate document when completed. Ethics is at the core of Spiritual SA's philosophy, and we will advocate for the spiritual industry to be considered legitimate and professional, and advance it as a positive, peaceful movement.

The Dark Side – Termination of Contract:
